RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

In consideration of being permitted to participate with Cycle Oregon Inc. and the Cycle Oregon Foundation in the year 2026 and any related Kids Bike Camps and activities (collectively the "Kids Bike Camp"), the undersigned, for themself, and their personal representatives, heirs, spouse, parents, siblings, and children, hereby acknowledges and agrees to the following:

1. I acknowledge and agree that riding bicycles on roads and my participation in Kids Bike Camp bears certain known and unknown risks which could result in injury, death, illness, disease, or damage to me, to my property, or to other parties. Risks include, but are not limited to those caused by terrain, facilities, temperature, weather, my physical condition, equipment, vehicular traffic, and actions of other people including participants, volunteers, spectators, and/or the Released Parties (as defined below). I acknowledge that the Released Parties have made no representations or guaranties as to the safety of Kids Bike Camp to me, and that I

KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, whether known or unknown.

2. I, for myself and on behalf of my heirs, assigns, and legal representatives, **VOLUNTARILY RELEASE, FOREVER DISCHARGE, AND AGREE TO HOLD HARMLESS AND INDEMNIFY** Cycle Oregon, Inc. and the Cycle Oregon Foundation, other participants or volunteers in Kids Bike Camp, sponsors or advertisers of the Kids Bike Camp, and if applicable, owners and lessors of premises used to conduct the Kids Bike Camp, and all officers, agents, volunteers, contractors, and employees of each of the foregoing persons or entities, all of whom shall collectively be referred to as the "Released Parties," or individually as a "Released Party," from any and all liability, claims, demands, or actions for any injury or death to me, for injury to my property, or for which I may be liable to others, which are in any way connected with my participation in Kids Bike Camp. **I AGREE AND UNDERSTAND THAT THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT WILL EXTEND TO ALL CLAIMED WRONGFUL ACTS OF THE RELEASED PARTIES TO THE GREATEST EXTENT ALLOWED UNDER THE LAWS OF THE STATE OF OREGON, INCLUDING THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES.**

3. I hereby represent that I am physically capable of participating in Kids Bike Camp, that my bicycle and any other equipment I may use to participate in Kids Bike Camp is in good working condition, that I will observe all applicable traffic laws and Kids Bike Camp rules, that I will wear a helmet that meets the ANSI or SNELL bicycle safety standards, ride no more than two abreast, obey all pertinent traffic laws and the directions of all traffic control personnel, use appropriate hand signals when turning, be equipped with proper lighting if riding between sunset and sunrise, and generally conduct myself in a safe and prudent manner while participating in Kids Bike Camp.

4. I hereby consent to and permit emergency treatment in Kids Bike Camp of injury or illness while participating in Kids Bike Camp.

5. I give permission to Cycle Oregon, Inc. and the Cycle Oregon Foundation, and its assigns and licensees, to use my name and any photographs taken of me during Kids Bike Camp in any promotional materials or publications.

6. I represent that without the permission of the organizer of Kids Bike Camp I will not transfer my right to participate in the Kids Bike Camp to any other party or encourage any other party to participate in Kids Bike Camp, unless registered with the organizer, and will hold harmless and indemnify the Released Parties from any liability of the Released Parties because this representation is found to be untrue.

7. I understand and agree that Cycle Oregon, Inc. and the Cycle Oregon Foundation, at its sole discretion, has the right to cancel or reroute all or any part of a Cycle Oregon Kids Bike Camp due to the occurrence of any *force majeure* event or credible threat thereof, including but not limited to any Act of God, fire, earthquake, acts of civil or military authority, casualty, flood, war, terrorist attack, epidemic, insurrection, civil unrest, strikes or other labor activities or any other similar cause beyond the reasonable control of Cycle Oregon Inc. or the Cycle Oregon Foundation, including environmental conditions that might threaten the health and safety of Kids Bike Camp participants, volunteers or staff. I understand and agree that my registration fees and

other costs will not be refunded by Cycle Oregon, Inc. or the Cycle Oregon Foundation if all or any portion of a Cycle Oregon Kids Bike Camp is cancelled or rerouted due to a *force majeure* event. I will release and hold Cycle Oregon Inc. and the Cycle Oregon Foundation harmless for any costs or damages incurred as result of cancellation or rerouting of a Cycle Oregon Kids Bike Camp due to a *force majeure* event.

ALL DISPUTES BETWEEN MYSELF AND ANY RELEASED PARTY ARISING FROM MY PARTICIPATION IN KIDS BIKE CAMP WILL BE GOVERNED BY THE LAWS OF THE STATE OF OREGON, AND THE EXCLUSIVE JURISDICTION THEREOF SHALL BE IN THE STATE COURTS OF THE STATE OF OREGON, AND THE VENUE FOR THESE DISPUTES SHALL BE IN MULTNOMAH COUNTY, OREGON.

IF ANY PART OF THIS AGREEMENT IS DETERMINED TO BE UNENFORCEABLE FOR ANY REASON OR UNDER ANY CIRCUMSTANCE, IT IS INTENDED THAT ALL OTHER TERMS WILL BE ENFORCED IN ALL OTHER CIRCUMSTANCES.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME, AND I INTEND MY SIGNATURE TO CONSTITUTE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAWS OF THE STATE OF OREGON.

I HAVE NOT RELIED ON THE ADVICE OR INPUT OF ANY RELEASED PARTY ABOUT THE INTERPRETATION OR EFFECT OF THIS AGREEMENT, AND FURTHER ACKNOWLEDGE THAT NO RELEASED PARTY HAS THE AUTHORITY TO MAKE ANY REPRESENTATIONS CONCERNING THE INTERPRETATION OR EFFECT OF THIS AGREEMENT, OR TO VERBALLY LIMIT OR MODIFY ANY TERM OF THIS AGREEMENT.
